The Master of Science (MSc) is a graduate program by research which is well recognized at both national and international levels.

There are eleven (11) fields offered by the school in this program namely Economics, Business Economics, Tourism, Hospitality, Management, Human Resource Management, Marketing, Finance, Accounting, Corporate Leadership and Business Law.

Candidates pursuing the degree should be capable of conducting independent research in their fields or related areas. Graduates from this program can be employed in academia, research institutions or public and private agencies.

Candidates are required to provide a brief outline of their proposed research to ensure that their research interests match the expertise of school members. Upon enrolment, each candidate will be assigned to an academic advisor, who will guide them in organizing their studies.

PROGRAM REQUIREMENTS

The Master of Science program consists of course work, thesis and seminar.

Master's Research

A Master's of Science student is required to register for SPS5999 (Masters Research) every semester. This is a research project, whereby, at the end of the study period the student will submit a thesis.

Credit Requirements

6 credits consisting of a compulsory **research methodology course (3 credits)** and an **elective course (3 credits)**.

Seminar

Students are required to register for a seminar course which is offered every semester.

Master's Thesis

All Master's of Science students must present and pass the thesis examination. The thesis will be examined and a viva voce will be conducted to determine the students' competency in the field of study. Thesis topics must be related to the area of specialization and has to be approved by the Thesis Examination Committee (to be appointed by UPM).

Students are required to produce proof of publication based on the following:
