ENTRY REQUIREMENTS

MBA:

- Candidates must have a Bachelor's Degree or equivalent qualification in a related field with a minimum **CGPA of 3.000** and a minimum **1 (ONE)** year of work experience in a relevant field ; or
- Bachelor's Degree or equivalent qualification with a **CGPA between 2.500 – 2.999** and have a minimum of **2 (TWO)** years of work experience in a relevant field; or
- Bachelor's Degree or equivalent qualification with a **CGPA between 2.000 – 2.499** and a minimum of **5 (FIVE)** years of work experience in a relevant field.

Master of Economics, Master of Finance, Master of Entrepreneurship:

- Candidates must have a Bachelor's Degree or equivalent qualification in a related field with a minimum **CGPA of 3.000**; or
- Bachelor's Degree or equivalent qualification with a **CGPA between 2.750 – 2.999** and have a minimum of **1 (ONE)** year of work experience in a related field; or
- Bachelor's Degree or equivalent qualification with a **CGPA between 2.500 – 2.749** and have a minimum of **2 (TWO)** years work experience in a related field; or
- Bachelor's Degree or equivalent qualification with a **CGPA below 2.500** and have at least **5 (FIVE)** years of work experience in a related field.

ENGLISH REQUIREMENTS

- Band 5.5 - 6.0 for **IELTS** or
- Score 51 - 78 for **TOEFL** ; or
- Score 107 - 109 for **CIEP**
