11.	What are the required academic qualifications?	The candidate should possess a:
		<ul> <li>Bachelor's Degree or an equivalent qualification in a relevant field with a minimum CGPA of 3.000; or</li> </ul>
		<ul> <li>Bachelor's Degree or an equivalent qualification with a CGPA between 2.750 - 2.999 should have a minimum of 1 year working experience in a relevant field; or</li> </ul>
		<ul> <li>Bachelor's Degree or an equivalent qualification with a CGPA between 2.500 - 2.749 and a minimum of 3 years working experience in a relevant field; or</li> </ul>





		<ul> <li>Bachelor's Degree or an equivalent qualification with a CGPA below 2.500 and a minimum of 5 years working experience in a relevant field.</li> </ul>
12.	What are the English language requirements?	No English language requirements for local candidates.  International candidates whose first language is not English must obtain one of the following:  Band 6.0 for IELTS (Academic Version); or Score 65-78 for TOEFL (Internet-based); or Band 4 for MUET; or Score 59-62 for PTE Academic; or Score 109 for CIEP at ELS Language Centre, UPM  Note: The validity period of the English Language Proficiency score should not be more than five years.
