**DURATION : 1 YEAR**

The Master of Economics program began in 1994 and has successfully produced highly competent graduates from various parts of the world. The program provides a broad-based course of study in the applied field of economics, mainly financial economics, international economics, development economics, labour economics, as well as resource and environmental economics.

The program emphasizes a balance between theoretical knowledge and practical application that suits various stakeholders including policy makers, academicians, employees in public and private institutions, and those with a keen interest in economics related subjects. Students will acquire relevant skills in conducting economic research by taking courses in research methodology, econometrics, statistical techniques and a masters dissertation. They will also be exposed to current global economic issues and recent economic research tools and studies.

## ENTRY REQUIREMENTS

- Candidates must have a Bachelor's Degree or equivalent qualification in a related field with a minimum CGPA of 3.000; or
- Bachelor's Degree or equivalent qualification with a CGPA between 2.750 – 2.999 and have a minimum of 1 year of work experience in a related field; or
- Bachelor's Degree or equivalent qualification with a CGPA between 2.500 – 2.749 and have a minimum of 2 years work experience in a related field; or
- Bachelor's Degree or equivalent qualification with a CGPA below 2.500 and have at least 5 years of work experience in a related field; or
- Passed **Level 7** of Accreditation of Prior Experiential Learning (**APEL.A**) from Malaysian Qualifications Agency (MQA).





## ENGLISH REQUIREMENTS

For international candidates only:

- Band 5.0 - 6.0 for IELTS ; or
- Score 45 - 78 for TOEFL IBT (Including Home Edition); or
- Band 3 - 4 for MUET; or
- Score 47 - 62 for PTE Academic; or
- Score 106 - 109 for CIEP at ELS Language Centre, UPM

**Note : The validity period of the English Language Proficiency score should not be more than five years.**

## PROGRAM REQUIREMENTS

Candidates are required to complete a total of **40 credit hours of coursework**. The total credit hours include program **core courses** and **master dissertation (25 credit hours)** and **elective courses (15 credit hours)**
