## ABOUT BA IWW

Publish-WISE is a 24-month programme to support 40 ECRs in business and management with SDG-focused research. Malaysian ECRs are under-represented in top-tier journals largely due to limited international networks, mentorship, and funding guidance.

Publish-WISE addresses these gaps through four structured in-person workshops and sustained online mentoring, connecting participants with UK and US journal editors and leading scholars. The workshops provide hands-on training in manuscript development, peer-review simulations, grant-writing strategies, and structured presentation feedback, reinforced by tailored one-to-one mentoring, interim online support, and alumni networks, ensuring ongoing collaboration, accountability, and institutional embedding.

By strengthening high-impact publication outputs, funding literacy, and international networks, Publish-WISE accelerates career progression, enhances global academic visibility, and builds enduring research capacity, directly advancing Malaysia's knowledge-based economy ambitions.

## OBJECTIVES

### Building high-impact publishing skills

Equip 40 Malaysian ECRs with the skills to design, write, and revise manuscripts suitable for top-tier international journals, including training in peer review, manuscript structure, and SDG-aligned academic writing.

### Establish sustainable mentoring and research capacity

Provide long-term, structured one-to-one mentoring from UK, US, and Malaysian senior scholars to enhance research quality, accelerate career progression, and embed lasting research capacity within Malaysian institutions.

### Strengthen international networks and collaboration

Create durable international research networks and peer communities that enhance collaboration, co-authorship, grant readiness, and global academic visibility for Malaysian ECRs

### Improve grant-writing competence and institutional impact

Develop participants' ability to produce competitive, SDG-aligned grant proposals while embedding workshop methods, mentoring practices, and alumni networks into Malaysian universities for long-term institutional benefit.

### Address and reduce structural inequalities in research participants and outcomes

To reduce structural inequalities affecting Malaysian ECRs by ensuring inclusive recruitment, accessible training, and culturally sensitive mentoring that support under-represented groups – such as researchers from less-resourced institutions, rural areas, minority groups, women, and those facing socio-economic or disability-related barriers - so they can participate fully and benefit equitably from research development opportunities.

# SPEAKERS

## PROFESSOR DR. DOUGLAS CUMMING

Douglas Cumming, J.D., Ph.D., CFA, is a Professor of Finance and the Steven Shulman '62 Endowed Chair of Digital Innovation at the Stevens Institute of Technology. Previously, Douglas was the DeSantis Distinguished Professor of Finance and Entrepreneurship at Florida Atlantic University, Professor and the Ontario Research Chair at the Schulich School of Business, York University. Douglas has published over 260 articles in leading refereed academic journals (including 51 in Financial Times Top 50 journals) in finance, management, and law and economics, such as the Academy of Management Journal, Economic Journal, Journal of Business, Journal of Financial and Quantitative Analysis, Journal of Financial Economics, Review of Financial Studies, Journal of International Business Studies, and the Journal of Empirical Legal Studies. Douglas is the Managing Editor-in-Chief of the Review of Corporate Finance and the Journal of Alternative Investments. He is a former Co-Editor-in-Chief of the Journal of Industrial and Business Economics, Managing Editor-in-Chief of the British Journal of Management, Journal of Corporate Finance, and Corporate Governance: An International Review. He is the founding Editor of Annals of Corporate Governance and a former Co-Editor of Finance Research Letters and Entrepreneurship Theory and Practice. He is currently serving as an Associate Editor for Economic Modelling, European Journal of Finance, Journal of Banking and Finance, Studies in Economics and Finance, amongst others.



## PROFESSOR DR. FANG LEE COOKE

Fang Lee Cooke is a Distinguished Professor at Monash University and also a Fellow of the Academy of the Social Sciences in Australia. She was a panel member of the United Nations Environment Programme-International Sciences Council (UNEP-ISC), foresight Expert Panel. She is the author of co-author of more than 100 academic journal articles and book chapters. Her work regularly appears in Human Relations, Human Resource Management, Human Resource Management Journal, Journal of World Business, Work, Employment and Society, British Journal of Management, Journal of Management Studies, British Journal of Industrial Relations, International Journal of Management Review, Human Resource Management Review, The International Journal of Human Resource Management, Journal of Business Research, amongst others. She is currently the Co-Editors-in-Chief of Human Resource Management, Asia Pacific Journal of Human Resource Management, International Business Review, and the International Journal of Human Resource Management. Furthermore, she is an Associate Editor for Management and Organization Review, Consulting Editor for the Journal of World Business, and sits on the Editorial Board for Human Resource Management Journal, Human Resource Management Review, Journal of Industrial Relations, New Technology, Work and Employment and Personnel Review.

## PROFESSOR VÉRONIQUE AMBROSINI

Véronique Ambrosini is a Professor of Management (Strategic Management) at Monash University (Australia). She is the previous Head of the Department of Management. She was previously a Professor of Strategic Management at the University of Birmingham and at Cardiff University (United Kingdom). She started her career at Cranfield School of Management (United Kingdom) where she gained her PhD. Her research interests include dynamic capabilities, business ecological sustainability, tacit knowledge, causal ambiguity, value creation and critical management education. Her articles have been published in internationally recognized academic journals such as the Academy of Management Learning & Education, Journal of Management, Journal of Management Studies, British Journal of Management, Long Range Planning, International Journal of Human Resource Management, Journal of Business Ethics or Human Relations and practitioner oriented journals such as European Management Journal and Management Decision. She is the author of 'Tacit and ambiguous resources as sources of competitive advantage', a co-author of 'How to develop a sustainable business school?', the editor of 'Exploring techniques of analysis and evaluation in strategic management', a co-editor of 'Advanced strategic management: A multi-perspective approach' and of 'Business Strategies for Sustainability'. Véronique is an internationally recognised scholar as reflected amongst others by the following. She is a British Academy of Management (BAM) Fellow and an Australia and New Zealand Academy of Management (ANZAM) Fellow. She is also a Fellow of the Academy of Social Sciences (UK). She is a former associate editor of the British Journal of Management and of the Journal of Management & Organization. She serves on the editorial board of the Journal of Management Studies, Academy of Management Learning & Education, and the International Journal of Human Resource Management. She is a past council member of the British Academy of Management and past chair of the Strategic Management Society Strategy Practice track.

Jeremy Eng-Tuck Cheah is Associate Professor of Decentralised Finance at Nottingham Trent University. His published work appears in ABS-ranked peer-reviewed journals including the European Journal of Operational Research (ABS 4; ABDC A\*), Human Resource Management US (ABS 4, ABDC A; FT50), Journal of Business Ethics (ABS 3; ABDC A, FT 50), British Journal of Management (ABS 4; ABDC A\*), Journal of Futures Markets (ABS 3; ABDC A), International Review of Financial Analysis (ABS 3; ABDC A), European Journal of Finance (ABS 3; ABDC A), Journal of Environmental Management (ABS 3), Economics Letters (ABS 3; ABDC A); Annals of Operations Research (ABS 3; ABDC A), Studies in Higher Education (ABS 3; ABDC A), Financial Review (ABS 3; ABDC A), International Journal of Finance and Economics (ABS 3) and Cambridge Journal of Economics (ABS 3; ABDC A), covering topics in decentralised finance, cryptocurrency markets, and financial economics. He has secured recognition through appointment to multiple UK Research and Innovation (UKRI) peer review colleges, including ESRC, EPSRC, and NERC, where he evaluates national-level research funding applications. He also serves on the British Academy of Management Peer Review College, contributing to research assessment across management and finance disciplines. He is also the Executive Guest Editor for a Special Issue on AI in Accounting and Finance Research and Practice for the British Accounting Review (ABS 3; ABDC A\*). Jeremy is also a regular reviewer for over 26 journals including Review of Economic Studies (ABS 4\*; FT50), European Economic Review (ABS 3; ABDC A); European Management Review (ABS 3), International Business Review (ABS 3; ABDC A), Journal of Banking and Finance (ABS 3; ABDC A\*), Journal of Business Research (ABS 3; ABDC A), Journal of Financial Stability (ABS 3; ABDC A), Journal of International Financial Markets, Institutions and Money (ABS 3; ABDC A) and other journals he publishes in. His paper on negative bubbles and cryptocurrency won the 2016 Tom Fetherstone Best Paper Award, published in the International Review of Financial Analysis (ABS 3; ABDC A) in 2019. He is the founder and organiser of the online Contemporary Issues in Financial Markets and Banking (IFMB) conference series, which facilitates international academic participation and includes linked journal special issues, and he established the Mid-Career Academic Network for Finance (MAN), which delivers workshops and structured events for finance scholars. Within his institution, he holds responsibility for doctoral research training as Joint PhD Coordinator (Accounting & Finance) and has been selected for the Vice-Chancellor's Future Research Leaders Programme.

Her recent research emphasizes ecosystems, the circular economy, and interdisciplinary approaches to sustainable innovation. She has published extensively in leading international journals such as Long Range Planning, Journal of Business Research, Technological Forecasting and Social Change, IEEE Transactions on Engineering Management, Business Strategy and the Environment, Industrial Marketing Management, and has expertise in circular economy, business innovation, digital transformation, and societal sustainability. Beyond research, she contributes to global academic quality assurance and doctoral examination, and plays an active leadership role in the academic community, including the BAM Peer Review College, Associate Editor for the International Journal of Management Review, and Guest Editor for Technovation; Resources, Conversation and Recycling.
