Basic Workshop on Structural Equation Modelling (SEM) Using AMOS

Speaker: DR. ANUSUIYA SUBRAMANIAM

Provide participants with a comprehensive understanding of SEM techniques. The workshop covered both theoretical foundations and practical applications of SEM, highlighting its role as a confirmatory analytical tool that extends the General Linear Model (GLM). Participants were introduced to key components such as Confirmatory Factor Analysis (CFA), path analysis and multiple regression. SEM is a second-generation statistical analysis technique developed for analysing the inter-relationships among multiple variables in a model.

In addition, the workshop emphasised the distinct advantages of SEM over multiple regression methods, including its ability to handle measurement errors, model mediators and moderators, and test models with multiple dependent variables. The two core SEM model types—measurement and structural—were thoroughly discussed, alongside guidance on interpreting SEM outputs. Participants also received hands-on training in using AMOS with SPSS files and demonstrated advanced techniques such as multi-model path analysis and tests for mediation and moderation effects.

Data Envelopment Analysis: Efficiency & Productivity in Decision Making Units

Speaker: ASSOC. PROF. DR. FAKARUDIN KAMARUDIN

Provide participants with a fundamental concepts of Data Envelopment Analysis (DEA) and its role as a non-parametric method for evaluating the relative efficiency of decision-making units (DMUs). The session covered the evolution of DEA, its key advantages, the various methodological approaches, as well as the decomposition of DEA efficiency scores and the DEA-based Malmquist Productivity Index (MPI) to understand productivity changes over time.

Additionally, participants were guided through the interpretation of DEA results under both the Constant Returns to Scale (CRS) and Variable Returns to Scale (VRS) assumptions. Participants were guided on how to interpret input and output slacks, identify peer (reference) units, and evaluate the target input and output values for inefficient units. The session also explained the distinction between technical efficiency, pure technical efficiency, and scale efficiency.

Data Envelopment Analysis – Efficiency & Productivity in Decision Making Units

Speaker: DR. SOH WEI NI

Provide participants with a comprehensive understanding of Data Envelopment Analysis (DEA) as a non-parametric approach for measuring efficiency, productivity, and performance across decision-making units. The workshop equips participants with the knowledge and practical skills to evaluate cost efficiency, allocative efficiency, and technical efficiency, as well as to apply the Malmquist Productivity Index (MPI) in measuring productivity changes over time.

Additionally, participants gain hands-on experience in analysing real-world data by identifying appropriate inputs and outputs, applying CCR (CRS) and BCC (VRS) models, interpreting efficiency results, and proposing the most suitable analytical model. The course is designed to strengthen participants' analytical capabilities and support the application of DEA in research, policy evaluation, and organisational performance assessment.

Workshop Panel Data Analysis – Short Panels (Micro Panels)

Speaker: PROFESSOR DR. LAW SIONG HOOK

This course focuses on the interpretation of short panel-data estimates (where the number of cross-sectional unit (N) is greater than time series period (T), and the assumptions underlying the models that give rise to them. The workshop covers the analysis and implementation of linear, firm-level, dynamic panel data estimations.

The workshop aims to familiarize participants with panel data structures and equip them with core skills in using panel data methods. This will be achieved through a combination of short lectures and computer lab sessions, with greater emphasis on giving participants hands-on experience.
