ENTRY REQUIREMENTS

- Candidates must have a **Bachelor's Degree or equivalent qualification** in a related field with a minimum **CGPA of 3.0**; **OR**
- **Bachelor's Degree or equivalent qualification** with a **CGPA between 2.750 - 2.999** and have a minimum of **1 (one) years of work experience** in a relevant field; **OR**
- **Bachelor's Degree or equivalent qualification** with a **CGPA 2.500 - 2.749** and a minimum of **2 (two) years of work experience** in a relevant field; **OR**
- **Bachelor's Degree or equivalent qualification** with a **CGPA below 2.500** and a minimum of **5 (five) years of work experience** in a relevant field; **OR**
- Passed **Level 7 of Accreditation of Prior Experiential Learning (APEL.A)** from Malaysian Qualifications Agency (MQA).
