ENTRY REQUIREMENTS

- A Bachelor’s degree in Accounting with a minimum CGPA of 2.75, from a local or foreign university accepted by UPM Senate; **OR**
- A Bachelor’s degree in Accounting with a minimum CGPA of 2.50 from a local or foreign university accepted by UPM Senate and have at least one (1) year of work experience in a related field. Candidates are also subject to rigorous internal evaluation by the School of Business and Economics; **OR**
- A Bachelor’s degree in a related field with a minimum CGPA of 3.0 from a local or foreign university accepted by the UPM Senate; and subject to rigorous internal evaluation by the School of Business and Economics.; **OR**
- Bachelor’s degree outside the field of Accounting with a minimum CGPA of 3.00 from a local or foreign university accepted by the UPM Senate; and subject to rigorous internal evaluation by the School of Business and Economics. Candidates outside the field of accounting must take and pass the prerequisite courses of this program before starting the first semester of study; **OR**
- Bachelor’s degree in Accounting and related fields with a minimum CGPA of 2.50 from a local or foreign university accepted by the UPM Senate; and have at least five (5) years of work experience in a related field. Candidates outside the field of accounting must take and pass the prerequisite courses of this program before starting the first semester of study; **OR**
- A relevant professional accounting qualification equivalent to a bachelor’s degree in Accounting as accepted by UPM Senate

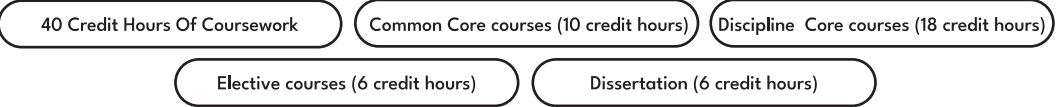
